Notary Public's Role in the Justice System

Notaries Public are usually appointed by an office within the state government where they reside. In Florida it's the Governor's Office. The main duty of a notary is to witness signatures on documents of a legal or financial nature. Some documents require the notary to administer an Oath attesting to the validity of the document & the signer's signature also known as a "Seal".

One of the vital duties of a notary is to positively identify the signer of any documents or legal instruments. My experience as a former NYC Police Officer has taught me how to identify fake identity documents.

The most common fake identity document presented is a driver's license. My knowledge of counterfeit licenses affords me the expertise to thwart frauds and con artists. Since a driver's license is a government issued certificate using it illegally can constitute a felony charge. Actually any official government issued document used in a fraudulent manner would constitute a felony. On more than one occasion I have been called to a location and found the person wanting to have a document signed is not the actual person the document is intended for. Since I can be held civilly and possibly criminally liable for an improper document I have refused service.

As a Private Investigator I accept assignments from insurance companies and law offices to investigate claims of accidents and crimes. My job is to obtain the facts of the case, but NOT to determine innocence or guilt. Every investigation involves interviewing claimants, defendants and witnesses. Usually, at the direction of the attorney or the insurance adjuster, I am tasked to obtain a sworn signed & notarized statement as to the circumstances surrounding the claim or the crime. Down the road these sworn statements can be used as exhibits in a court proceeding. In the past I have had to testify to the validity and authenticity of statements I have taken. If it turns out the person who swore to the statement lied it is a possibility that person could be held civilly and criminally liable under perjury laws.

On one occasion I was called to a local hospital to notarize a Power of Attorney for a man who claimed to be the son of a patient. Upon arriving I was met by a man who claimed his father needed to sign a *POA* (Power of Attorney) so he could access bank accounts and other financial accounts. I explained to the *son* I would have to interview and question the *father* to determine his frame of mind, if he was competent to understand what the document is he was signing.

I explained to the *son* I would need to do this alone. His response to me over that requirement was what started the hair to stand up on my neck. He insisted that he be present in the hospital room when I questioned his father. I reiterated that was not going to happen. At this point I decided to find out from the hospital social worker what was known about this patient and family situation without violating any HIPPA Laws.

I spoke to the social worker who told me the patient has been in the hospital for 6 months and never once did anyone ever come to see him. In the last few days the man claiming to be his son showed up with legal papers. At this point the social worker told me to go talk to the father and I will learn everything I need to know. I entered the room alone and found a man who looked disheveled and somewhat delusional. After a brief conversation in which I was told the President of The United States was Abraham Lincoln and the date was July 4th 1965, and I was his son, I concluded this man was NOT Compos Mentis.

A Student's Victory over Cancer by Janice Riter

"My mama always said, 'Life was like a box of chocolates. You never know what you're gonna get."-Forrest Gump One of my favorite movies is Forrest Gump and I think the quotes from that movie are "Priceless".

I was with my mother celebrating her birthday and we decided to drive to Anna Marie Island, FL and spend a couple of days at the beach relaxing, enjoying wonderful seafood dinners, listening to the waves hitting the beach and watching the beautiful sunsets disappear into the ocean.

On the day we were leaving and heading home mom wanted to have lunch one more time at one of our favorite restaurants and then I received the phone call that changed my life. As I looked at my cell I told mom it's the doctor's office. I had my annual mammogram before I left and wasn't worried because my mammograms had been normal in the past and the only time I did have one small issue it was discovered I have fibro cysts and the radiologist told me to keep my caffeine intake to a minimum and he assured me these would not turn into cancer.

As I answered the phone the office said they had been calling the house and needed to reach me pertaining to my mammogram came back abnormal and they need to schedule the ultrasound.

This was a couple of weeks before Thanksgiving 2015. I told them to set the appointment. Two days before Thanksgiving I am sitting with several women waiting to be called for the test. I finished my test and I was told to wait to get dressed as the Radiologist would look at the films. When the girl came in she told me she needs to take more pictures. After that she told me to get dressed and I will be talking to the doctor. As I sat and looked At the films I kept telling myself it's going to be fine. This was my breast that did not have the fibro cysts. My radiologist was a women and she said she reviewed all my past films and the area of concern was a little smaller then a pea and no one would have ever felt it in a breast exam and I needed a biopsy. I knew I needed to get the appointment as soon as possible.

December 10, 2015 I had my biopsy. My doctor received the report in a couple of days and now I am ready to receive my news. I have a wonderful relationship with him as he has been my mother's doctor for twenty eight years. When he sat down and looked at me and said "Janice if I have to tell any of my patients they have breast cancer I hope I can tell them your report of Stage 1 and the radiologist believe there is nothing in the lymph nodes and its estrogen receptive which is the best report I can tell my patient." My mother had joined us to discuss setting up the operation. Next my doctor is calling the surgeon on his cell who is another doctor we know. December 18th met with the surgeon and he advised he would perform a Lumpectomy and check the lymph nodes. The surgery is set for December 23, 2015.

Day of the surgery my minister arrives and has a wonderful prayer with me. My family is with me and my daughter only left my side when they pushed me through the doors to go into the operating room.

When I woke up in the recovery room my mother and daughter were immediately allowed to come in and told me the wonderful news that nothing new was found, my margins looked clear and my lymph nodes were clear. The finale pathology report confirmed what we were told after surgery.

After my follow up appointments with my medical doctor and surgeon they both said they did not believe I would need chemo but I need to see a Radiation Oncologist to discuss the possibility of treatments. I agreed to radiation and I was told to meet with a Medical Oncologist because of my cancer being estrogen receptive I may need to be on a prescription for five years to block estrogen.

I had an appointment with a Medical Oncologist a couple days before starting my radiation treatments. After she sat down in the room with me to discuss my case she advised me she could not make a determination if I should take a prescription because I may need Chemo! I couldn't believe what she told me. I told her she was the first doctor that even mentioned the word Chemo. She wanted to retest my tissue which would take three weeks to get the report back and I would not be able to start radiation until we discussed the report. Sometimes you need to do what is best for you. I knew this was my time.

I met with the son outside the room in the hallway and informed him I would not notarize the documents because his father was not, in my opinion, able to understand what he was doing. This did not sit well with the son who stated the papers were drawn up by the family attorney and he wanted them signed by his father. I informed him to have the attorney come to the hospital and notarize the documents, or contact the State of Florida Elder Affairs and have a guardian assigned to see to his affairs. This was not what he wanted to hear and stormed off.

I went back to the hospital social worker and updated her. I suggested she call the hospital administrator to notify the appropriate authority as to what had transpired. Some weeks later I was

called by the social worker who told me the man was not his son but a distant relative looking to gain control over the man's bank accounts. fter all that I was not paid for my time...LOL





I needed to ask questions. After a long discussion I told her to send the report of this visit to my medical doctor and I Am Getting a Second Opinion! I finished my 42 radiation treatments two days after Easter 2016. On May 4,2016 I went to the Cancer Treatment Centers of America in Georgia.

It was the best decision I made for my life. My new Medical Oncologist could not believe chemo was discussed. After reviewing my pathology report and entering my information from the pathology report into a computer program from Europe I had another in-depth report about my cancer.

After he reviewed that report he said he would not recommend or put me on one of the estrogen blocking prescriptions because of the side effects and I learned from the new report I had the cancer that is slow growing and I also had precancerous cells a long with Stage 1 cancer cells in the tissue.

He was in agreement with the radiation treatments. Going for a second opinion saved my body from going through unnecessary treatments. When you hear the word Cancer it can be very devastating and every person handles the situation differently. I know lots of women are not going to have a wonderful cancer report as I did and I often ask myself that question. Why? If my story helps you understand one women's journey with breast cancer I hope it will be; please don't be afraid to ask
